COMMONWEALTH OF KENTUCKY COUNTY OF CAMPBELL CITY OF COLD SPRING ORDINANCE NO. 18-1048

AN ORDINANCE AMENDING THE CITY OF COLD SPRING'S CODE OF ORDINANCES RE: THE PLACING OF TRAFFIC CONTROL DEVICES

Whereas, the City of Cold Spring has established uniform traffic regulations for roads in the City of Cold Spring, Campbell County, Kentucky, road system which are now included in the City of Cold Spring, Campbell County, Kentucky, Code of Ordinances, Title VII: Traffic Code, Section 73 Traffic Schedules; and

Whereas, the safety committee composed of the Mayor, Police Chief and Council members have met and reviewed certain streets within the City as they relate to vehicular traffic; and

NOW, THEREFORE BE IT ORDAINED BY THE CITY OF COLD SPRING, COUNTY OF CAMPBELL, COMMONWEALTH OF KENTUCKY:

Section I

The City of Cold Spring approves an amendment to the Code of Ordinances, Title VII: Traffic Code, Section 73 Traffic Schedules, which will authorize the placing of stops signs as set forth below and directs that the Public Works Department place the necessary signage.

- (1) At the location upon which Sandstone and Granite Spring Drive form an intersection so that traffic travelling in any direction must stop to form a four (4) way stop.
- (2) At the location upon which Marble Way and Granite Spring Drive form an intersection so that traffic travelling in any direction must stop to form a four (4) way stop.
- (3) At the location upon which Boulder View and Ledgerock Way form an intersection so that traffic entering Ledgerock Way from both directions on Boulder View must stop before entering.
- (4) At the location upon which Silver Ledge and Granite Spring Drive form an intersection so that traffic entering Silver Ledge from both directions on Granite Spring Drive must stop before entering.

The penalty for violation of this Ordinance shall be as set forth in the Kentucky Revised Statutes 189.990.

Section II

The City of Cold Spring approves an amendment to the Code of Ordinances, Title VII: Traffic Code, Section 70.38, creating a specific no parking zone as set forth below and directs that the Public Works Department place the necessary signage.

- (1) That no parking be established on Granite Spring Drive along the east side from Sandstone to Founders Court.
 - (2) Any person violating this no parking zone, shall be subject to a fine of \$50.00

Section III

That any section, or part of any section, or any provision of this Ordinance which is declared invalid by a Court of appropriate jurisdiction, for any reason, such declaration shall not invalidate, or adversely affect, the remainder of this Ordinance.

Section IV

This Ordinance shall take effect and be in full force when passed, published, and recorded according to law.
