CITY OF COLD SPRING, KENTUCKY EXECUTIVE ORDER NO. 20EXECUTIVE ORDER REGARDING OUTDOOR DINING

WHEREAS, on March 13, 2020 President Donald J. Trump declared a national state of emergency in response to the coronavirus, COVID-19, pandemic; and

WHEREAS, on March 6, 2020 Governor Andy Beshear declared a state of emergency in Kentucky in response to the first documented case of the novel coronavirus, COVID-19; and

WHEREAS, on March 17, 2020, by Executive Order 20-04, Cold Spring in response to the aforementioned State and National Orders, also declared a state of Emergency; and

WHEREAS, Governor Andy Beshear has ordered that beginning May 22, 2020, restaurants may begin to re-open, with limited seating, due to proper distancing and safety; and

WHEREAS, Cold Spring's restaurants' have already been financially burdened and assistance is needed to allow for maximum seating; and

WHEREAS, KRS 39A.100, provides for authority to protect Cold Spring's citizens, which also includes its business, in a manner similar to Governor Andy Beshear, ordering the businesses closures, Cold Spring man enacts Orders their operation; and

WHEREAS, Cold Spring's current zoning may prohibit the outdoor dining, which is encouraged by Governor Beshear, as well as necessary for Cold Spring's restaurants to begin recovery; and

NOW and therefore, I, D. Angelo Penque, Mayor of the City of Cold Spring, by virtue of the authority vested in my by KRS Chapter 39A and 39B of the Kentucky Revised Statutes, do hereby declare that any Cold Spring Zoning prohibitions, regarding outdoor dining, shall be suspended until such a time that Governor Andy Beshear allows Cold Spring's Restaurant's to return to normal business operations. That I encourage the Northern Kentucky Health Department to assist restaurants in any manner to effectuate and encourage assistance in any permitting or other required actions, so that Cold Spring's restaurants may begin their recovery. The sole exception shall be that any outdoor dining, which is not presently allowed under Cold Spring's zoning ordinance, shall end by 10:00 pm each day to insure it does not disrupt our residents.

This Declaration of State of Emergency shall remain in effect until terminated by the issuance of another Executive Order when I determine that a state of emergency no longer exists and the exercise of extraordinary measures are no longer required for the protection of the public health, safety and welfare.
