

THE CITY CONTINUED UTILIZING THE TECHNICAL ADVISORY COMMITEE (TAC) THAT MET 4 TIMES IN 2017 TO DISCUSS AND MAKE DECISIONS RELATED TO WATER QUALITY ISSUES AND THE STORMWATER UTILITY. THE FOLLOWING ARE THE 4 TAC MEETING DATES:

- A. TAC MEETING 1 FEBRUARY 9, 2017
- B. TAC MEETING 2 April 13, 2017
- C. TAC MEETING 3 MAY 10, 2017
- D. TAC MEETING 4 AUGUST 16, 2017
- THE CITY ALONG WITH CONSULTANT BAYER BECKER INC. MAINTAINS THE CITY'S WEBSITE WITH PUBLIC EDUCATION AND OUTREACH INFORMATION.
- 3. DURING 2017 COLD SPRING LAUNCHED A NEW WEBSITE ADDING MORE STORM WATER INFORMATION. BAYER BECKER WILL REVIEW, REVISE, UPDATE STORMWATER DOCUMENTS AND PAGES ON THE CITY OF COLD SPIRNG WEBSITE.
- 4. THE CITY OF COLD SPRING PUBLISHED TWO STORMWATER ARTICLES THAT WERE INCLUDED IN THE CITY OF COLD SPRING NEWSLETTER THAT WERE MAILED TO EACH OF THE 6,132 (100%) OF THE RESIDENTS.
- SWQMP FACT SHEETS WERE REVIEWED BUT NO REVISIONS WERE MADE.
- THE CITY OF COLD SPRING CONTINUED TO UTILIZE TELEVISED CITY COUNCIL MEETINGS, TAC/SWAC MEETINGS, WEBSITE DOCUMENTS, STORMWATER HOTLINE, FACT SHEETS AND NEWSLETTER ARTICLES DURING 2017.

CURRENTLY, COLD SPRING IS NOT AWARE OF A SPECIFIC PROBLEM POLLUTANT OR PROBLEM WATERBODY IN THE COMMUNITY. COLD SPRING TAKES A COMPREHESIVE APPROACH TO EDUCATE THE COMMUNITY RELATED TO WATER QUALITY. INCLUDING EDUCATIONAL INFORMATION ABOUT CHEMICALS, USE OF HERBICIDES/PESTICIDES, WATER CONSERVATION, YARD WASTE DISPOSAL, RECYCLING OF WASTES AND CONSTRUCTION SITE EROSION MANAGMENT. THE EFFORT/FOCUS IS TO EDUCATE THE COMMUNITY AT LARGE ALL RESIDENTS AND BUSINESSES.

THE CITY OF COLD SPRING IS COMMITTED TO PROTECT THE WATER SHED. THE STORM WATER UTILITY WAS ESTABLISHED TO MEET MS4 PERMIT REQUIREMENTS AND THIS ACTION HEIGHTENED AWARENESS ABOUT WATER QUALITY AND QUANTITY IN THE COMMUNITY. THIS HAS CAUSED MORE INTERACTION WITH OUR RESIDENTS AND IMPROVED WASTE DISPOSAL METHODS AND STORMWATER MANAGEMENT ON PRIVATE AND PUBLIC PROPERTY.

THE CITY OF COLD SPRING TECHINCAL ADVISORY COMMITTEE (TAC) A FORMAL DECISION MAKING BODY OF THE CITY COUNCIL AND THE ADMINISTRATION, CREATED A STORM WATER ADVISORY COMMITTEE (SWAC) AS ONE OF THE METHODS FOR MEASURING SUCCESS FOR REACHING THE CITIZENS AND HAS COMMITTED TO DEVELOPING MEASURABLE GOALS FOR THIS MCM DURING 2017 AFTER KDOW ISSUES THE NEW STORMWATER QUALITY PERMIT AND GUIDELINES. THE NEW PERMIT HAS NOT BEEN RELEASED AND THIS IS STILL PENDING

THERE WERE 8 STORMWATER COMPLAINTS RECEIVED BY THE CITY FOR THE YEAR OF 2017:

001 - EROSION AND FLOODING IN BACKYARD - CAUSE IMPROPERLY MAINTAINED CATCH BASINS AT BUSINESS UPHILL FROM RESIDENCE, HAD BUSINESS START REGULAR MAINTENANCE.

002 - EROSION OF DRIVEWAY GRAVEL - CAUSE CROWN ON STREET AND INTERSECTION - HAD OWNER REGRADE DRIVEWAY. ASPHALT ROAD PROJECT CORRECTED CROWN IN ROAD.

003 - BACKYARD FLOODING - CAUSE NEIGHBORS HAD GUTTERS DAY LIGHTED, - NOT CITY ISSUE PRIVATE MATTER 004 - EXCESSIVE FLOODING REAR YARD CAUSED BASEMENT FLOODING - CAUSE HOUSE IS BUILT AT BASE OF TWO HILLS. #### **Executive Summary**

#### Introduction:

Please be advised, the City of Cold Spring, KY. has collected and compiled data/information for permit year 2017 (January through December). This information represents Cold Spring activities under the Municipal Separate Storm Sewer System (MS4) Phase II General Permit No. KYG200055 and is being submitted to Ms. Abigail Rains, Storm Water Program Coordinator, Kentucky Division of Water.

On March 31, 2015, the Kentucky Pollutant Discharge Elimination System Permit No.: KYG2000000, General Permit for Phase II Municipal Separate Storm Sewer Systems (MS4) expired but is administratively extended until a new permit is issued. To date a new permit has not been issued. The City of Cold Spring is committed to following the rules set forth in the extended permit. During this report period the City of Cold Spring made no changes to the SWQMP and has not added any new programs awaiting the release of the new permit.

The Annual Compliance Inspection was performed on September 12, 2017 by Abigail Rains and no problems were found.

Collection of storm water utility fee's continued and rates for service have not changed this period. Stormwater revenues are deposited in a special fund to be spent only for stormwater services. Fees are calculated based on a \$4.50 monthly rate per Equivalent Residential Unit (ERU).

There were no illicit discharges reported in the Annual Report documents.

Bayer Becker Inc. continues to provide stormwater support services for the City of Cold Spring, KY.

- 3. As needed Bayer Becker Inc. will review, revise, update stormwater documents and pages on the city of Cold Spring website.
- 4. The city of Cold Spring published two stormwater articles that were included in the city of Cold Spring newsletter that were mailed to each of the 6,132 (100%) of the residents.
- 5. SWQMP fact sheets were reviewed but no revisions were made.
- 6. The city of Cold Spring continued to utilize televised city council meetings, TAC/SWAC meetings, website documents, stormwater hotline, fact sheets and newsletter articles during 2017.

#### B. Public Involvement and Participation:

1. One Storm Water Advisory Committee (SWAC) meeting was held on December 27, 2017. The city of Cold Spring Administrator, Steve Taylor and Dave Crouch, Bayer Becker Inc. reviewed information about MS4 program activities during 2017. Power Point handouts were provided to the SWAC.

#### C. Illicit Discharge Detection and Elimination:

The city of Cold Spring had no illicit discharges in the city during 2017.

#### D. Construction Site Stormwater Run-Off Control:

There was one active construction site, Cracker Barrel, 4210 Alexandria Pike during this report period.

#### E. Post-Construction Stormwater Management in New Development and Redevelopment:

Per ordinance the city of Colds Spring retains and follows SD1 regulations.

## F. Pollution Prevention and Good Housekeeping for Municipal Operations:

The city of Cold Spring practices good housekeeping at all city owned and operated facilities.

#### **Cold Spring Projects 2017:**

- Winters lane existing brick laid collection box was destroyed by heavy truck replaced with new precast 3' by 3' collection box.
- Friendship Park installed new precast 2' by 2' yard box and approximately 80 feet of 8-inch ADS storm pipe and an additional 160 feet of 4 inch perforated rigid pipe. All pipe connected into existing collection box.
- Municipal park 2' by 2' collection box was installed and approximately 60 feet of 6-inch schedule 40 pipe that drains into 3 separate gravel filled holding areas covered in filter fabric.
