Cold Spring City Council July 27, 2020

The July 27, 2020 special council meeting was called to order by Mayor Penque at 6:30pm via teleconference.

Roll Call:

- Present: Mayor Angelo Penque, Councilmembers Paul Kloeker, Cindy Moore, Adam Sandfoss, Lisa Cavanaugh, City Administrator Steve Taylor, and City Clerk Robin Morency, Police Chief Steve Collinsworth, Public Works Director Ron Hitch, and City Attorney Brandon Voelker.
- Excused: Council members Michael Ruscher and Chris Ampfer

Minute Approval::

- June 4, 2020 Special Council Meeting Minutes Cindy Moore made a motion to approve the meeting minutes as amended per her request from the previous meeting. Adam Sandfoss seconded the motion. Roll call votes shows 4yeses and 0 noes. **Motion** passed.
- July 13, 2020 Special Council Meeting Minutes Adam Sandfoss made a motion to approve. Cindy Moore seconded the motion. Roll call vote shows 4 yeses and 0 noes.

Ordinance 20-1066:

 2nd reading to adopt an ordinance establishing rules at the Robert J. Barth Park. Roll call vote shows 3 yeses and 1 no - Cavanaugh. Motion passed

Discussion:

- Duke Franchise Agreement Brandon Voelker advised the council that like most cities, our agreement for gas and electric with Duke has expired. Adam Sandfoss asked how long the agreement will be for. Brandon Voelker said that it can vary but you don't want it to exceed 20 years; he advises to make it for at least 10 years.
- Comments from Council Adam Sandfoss reminded everyone to wash their hands and wear a mask. Cindy Moore wanted to share some concerns from residents. The first concern is that the trucks coming in and out of the intersection at US 27 and 1998 run the light all of the time. The second concern is that people who are turning into Orchard Terrace are being passed by drivers going into the emergency lane. The third concern is the intersection at US 27 and East Alexandria Pike. There was discussion about the turning lanes from Matinee and US 27. Adam Sandfoss that no one has the right-of-way, you are supposed to stay in the inner lane if you are going north from Matinee, and the outer lane if you are turning right from East Alexandria Pike. Steve Taylor advised her to tell the resident that the City has requested that the state paint the dotted lines for each lane and the state has refused. Brandon Voelker stated that the AA was painted and some peoples cars were hit with paint because the mixture wasn't correct, he will send forms to the City if anyone needs them.

The Executive Session was cancelled.
