Discussion – conditional use for storage units

Citizen Comments:

- A gentleman addressed Cindy Moore stating that she has demonstrated herself poorly, asked that she get help and resign
 immediately as he feels that she is unfit to hold her position on council and carry out her responsibilities by taking a
 position of hate and racism towards Mr. Beasley.
- Mr. Steve Trauth addressed council about an issue with catch basins being clogged. Mr. Trauth spoke about an article that
 he saw in Ft. Thomas Matters that needs to be corrected in regards to Cold Spring's tax rate. Mr. Trauth then talked about a
 letter that has been passed distributed to residents and spoke about a few topics that were mentioned in the letter. He told
 council that the letters and false facts need to be stopped, he said Cold Spring can do better.

New Business:

- Discussion about changing the ordinance in regards to storage of RV's, boats and trailers Paul Kloeker said that violations
 of storage are what is on the Code Enforcement report the most, he thought it was worth looking into changing the rules
 and mentioned possibly a seasonal exception. Lisa Cavanaugh said she is open to the idea. Chris Ampfer and Adam Sandfoss
 suggested reaching out to other cities to see what their rules are. Brenda Helton suggested issuing permits.
- Discussion regarding changes to add outdoor dining as a conditional use Brandon Voelker stated what is currently in effect is an executive order that suspended zoning to allow for the outdoor dining. Mr. Voelker asked if council wants to consider allowing more outdoor dining permanently so there wouldn't be tents outside of all the restaurants, this would be a conditional use permit in every zone.
- Steve Taylor asked if the City wants to entertain adding self-storage as a conditional use in certain zones.

Follow up Citizen Comments:

• Kevin Farmer addressed Councilwoman Moore, asking her to resign because they don't feel that she can do her job appropriately and that she needs sensitivity training. Mrs. Moore thanked him for his comments and said that she will let the citizens decide whether she should be on council on November 3rd and that she has been in many situations with people of different races and she would be happy to meet Mr. Farmer to discuss further.
