

## Cold Spring Council Minutes

April 26, 2021

The April 26, 2021 council meeting was called to order by Mayor Penque at 7:30pm.

Prayer and pledge were led by the City Clerk.

### *Roll call:*

### *Items of Interest to the Community:*

- Mayor Penque shared with the residents that construction is moving right along. He added that Public Works is almost done with the installation of the gazebo at the lake park and soon there will be picnic tables and some steel swings.

She stated that they do not receive any services from the city and they surrounding properties are all in Unincorporated Campbell County. There was some discussion about the history of the properties, as well as what could be done with that property in the future. Brandon Voelker told the residents that they would need to get a survey done to move forward. Jason Louis, who is one of the residents that also wants to be de-annexed stated that Campbell County told them that they would take the property back if the City were to vote to de-annex. The City Council requested that they provide proof of that statement from the county.

### *Unscheduled Guests:*

- Mike Hasl made a proposal to the council that they install pickleball courts within the city. Mr. Hasl stated that this is a very popular sport right now and they are having to travel to neighboring cities and over into Cincinnati to find places to play. Mr. Hasl provided the council with a packet with some information on how much space is needed for a pickleball court and stated that he would like to start a committee for planning of this. There was some discussion and a few ideas thrown around about where there might be space for a court within the city.
