#### Old Business:

Ordinance 21-1072, 2<sup>nd</sup> reading to adopt an ordinance amending the zoning map of the City of Cold Spring, County of Campbell, Kentucky for an approximate 1.0 acre on Alexandria Pike/US 27 approximately 600 feet north intersection of Alexandria Pike and Crossroads Boulevard from Highway Commercial\* (HC\*) to Highway Commercial (HC). Adam Sandfoss made a motion. Chris Ampfer seconded the motion. Paul Kloeker stated that this is for the Starbucks location. There was discussion about Kentucky Transportation Cabinet District 6 (KYTC6) and how they are trying to reduce north and south bound traffic by limiting curb cuts on US 27. Roll call vote shows 5 yeses and 0 noes. Motion passed.

Brandon Voelker stated that this is the old Goetz TV site and allowing this change will make the zoning consistent with the surrounding properties. Roll call vote shows 5 yeses and 0 noes. **Motion passed.** 

Approval of easement for Duke Energy – Steve Taylor stated that we need to grant them this easement
to run the power line from East Alexandria Pike to the community center, then from the community
center to the transformer behind the police department, he added that council needs to approve since it
is public grounds. They will also put in a junction box in case power will need to be upgraded for the
existing three buildings. Paul made a motion to approve. Lisa Cavanaugh seconded the motion. Roll call
vote shows 5 yeses and 0 noes. Motion passed.
