#### CODE ENFORCEMENT

There are many different ordinances that relate to maintaining our city in a neat and orderly condition. Some of the most common violations are listed below:

- Unlicensed and inoperable vehicles in a residential zone shall not be stored unless it is in a completely enclosed building.
- Parking in the yard is prohibited.
- Recreational vehicles, including campers, boats and trailers etc. shall be stored in the rear yard on a hard surface, or in a completely enclosed building.
- Unkempt and deteriorated buildings are not allowed.
- Debris, litter, rubbish salvage materials, motor vehicle tires, or miscellaneous refuse shall not be openly stored.
- Weeds and unmowed lawns are not acceptable.
- Temporary signs will not be allowed unless a permit is issued from the city building.
- It is unlawful for any owner, keeper or walker of any animal to permit his or her animal to discharge such animal's excrement upon any public or private property, other than the property of the owner of any such animal within the city if such owner, keeper, or walker does not immediately thereafter remove and clean up such animal's excrement from the public or private property
- It is unlawful for any animal owner to permit such animal to leave the premises of where the animal is usually kept except when on a leash. You shall not allow your animal to run at large allow them to go on another persons property

Summer has come and gone, so it won't be long until the leaves change and start to fall. Leaves falling in the street is one of our biggest problems for our stormwater catch basins. Please, **DO NOT** blow leaves into the street or into catch basins! We routinely check and clean catch basins in the fall so there are no obstructions. Leaves can plug stormwater drains and create bigger problems.

Just a reminder, city ordinance 91.50 prohibits anyone depositing litter, trash and/or debris into city streets.

Who knows what kind of winter weather we will receive this year. As always, we will do our very best to keep streets safe and passable. Just a reminder of our plowing and salting procedures; hills and the main streets in the neighborhoods are our first priority. Then we move on to side streets and flatter streets. The city is broken down in four routes for our drivers. The conditions will determine how long it takes to go from start to finish on that route. All snow gets plowed to the right on every street. This means you will get snow in your driveway from road plow. This is the most efficient way for us to plow. Please help us this winter by parking in driveways when inclement weather is predicted.

#### It's TAX TIME!

Tax bills will be mailed out mid-October. If a mortgage company has requested your tax bill, that is where it will be sent. If you wish to receive a copy of the tax bill that was sent to the mortgage company, please call the city building and we will be happy to mail or email you a copy. Property tax rates have gone down this year, the real property tax rate is .153 per \$100 dollars of the assessed value and tangible taxes are .154 per \$100 of the assessed value, the motor vehicle tax rate stayed the same at .169 per \$100 of the assessed value and the trash rate for 2022 is \$219.00. Please let us know if you need a receipt after payment and we will send one to you.

If you have not already done so, you can request to be added to the Cold Spring Email Distribution List by emailing me at robin.m@coldspringky.gov. We use this to send out important information in between newsletter mailings.

I am happy to announce that we are in the process of setting up the capability to accept credit card payments. As soon as this is finalized, we will be sure to make an announcement via Facebook, our website, and the email distribution list.

If you have questions or concerns about trash pick-up and the city building is closed, you can call Rumpke at 859-472-7339. You can also call this number to notify Rumpke of a large item that you need picked up.

**Reminder:** Trash pick up will be delayed by one day the week of Christmas and New Years! Please set your cans out on Friday night so that Rumpke can pick up on Saturday, instead of Friday.

Keep in mind that the city building will be closed on the following days:

- November 11- Veterans Day
- November 25 and 26 Thanksgiving
- December 24 and 25 Christmas
- January 1- New Years Day



#### Should I Care About Stormwater?

Does stormwater really affect me? Whether you live in a town, the country, a city, or the suburbs, when it rains the water that runs off goes somewhere. Stormwater affects everyone!

We are all part of some watershed. Watersheds are land areas that drain to the nearest body of water. Almost all of our roof lines, yards, driveways and streets drain to small local creeks and streams that drain into larger water bodies.

Flooding: when excess water has nowhere to go, flooding can impact property, cause damage to land and structures. Flooding can also be a public safety issue that affects entire communities.

Pollution and Health Impacts: Stormwater picks up anything that is on the ground and carries it along with it. Animal waste, chemicals, pesticides, oil, trash, and sediment – all of it ends up in the waterways and can potentially end up in our sources of drinking water.

**Streambank Erosion:** Uncontrolled stormwater can cause streambank erosion, leaving bare soil and exposing tree roots. This could lead to property damage and cause issues with streambank stability.

Sedimentation: Erosion and runoff, can also lead to sedimentation. Sedimentation of waterways from runoff causes changes to aquatic habitats. Undesirable plant growth increases, water becomes cloudier, which then disrupts the aquatic ecosystems. Sedimentation also fills in waterways, which also can increase the potential for flooding.

Impacts to Recreational Opportunities: Stormwater runoff can cause polluted waterways which can lead to restrictions on boating, swimming, and fishing in our recreational areas.

Making changes to how stormwater is managed can go a long way to reduce all of these negative impacts. Even the small actions taken by individual homeowners like rain barrels, choosing permeable landscaping surfaces or installing a rain garden can make a difference. Stormwater affects everyone!

Together we can protect our streams and rivers. Remember only RAIN should go down the DRAIN!
