- Ordinance 22-1076, 2nd reading to adopt an ordinance amending the City of Cold Spring, KY amended budget for the fiscal year July 1, 2021 through June 30, 2022. Paul Kloeker made a motion. Lisa Cavanaugh seconded the motion. Roll call vote shows 6 yeses and 0 noes. **Motion passed.**
- Ordinance 22-1077, 2nd reading to adopt an ordinance adopting the City of Cold Spring, KY annual budget for the fiscal year July 1, 2022 through June 30, 2023. Lisa Cavanaugh made a motion. Kenny Sears made a motion. Paul Kloeker asked for some details about the ARPA funding in regards to

premium pay, playground improvements, and donation to the Central Campbell Fire Department. Roll call vote shows 6 yeses and 0 noes. **Motion passed.**

- Ordinance 22-1078 – 2nd reading to adopt an ordinance adopting the pay plan for the fiscal year July 1, 2022 through June 30, 2023. Kenny Sears made a motion. Paul Kloeker seconded the motion. Paul Kloeker asked that Code Enforcement be added to the pay plan. There was discussion about the event coordinator position and salary versus hourly pay. It was also requested that positions that have been vacant for several years be removed from the pay plan. Kenny Sears and Lisa Cavanaugh withdrew their motion. Kenny Sears made a motion to approve the ordinance after removing the vacant positions: Finance Director, Finance Secretary, Admin Secretary, Receptionist, Public Works Supervisor, Janitor, Captain, and the Park Board positions, as well as converting the event coordinator from hourly to salary pay range of \$45,000 to \$60,000. Paul Kloeker seconded the motion. Roll call vote shows 6 yeses and 0 noes. **Motion passed.**
