June 14, 2021

The June 14, 2021 special council meeting was called to order by Mayor Penque at 7:30pm.

Roll call:

- Present: Mayor Angelo Penque, Chris Ampfer, Lisa Cavanaugh Deanna Hengge, Paul Kloeker, Cindy Moore, Adam Sandfoss (arrived at 7:32pm), City Administrator Steve Taylor, City Clerk Robin Morency, City Attorney Brandon Voelker, and Police Chief Steve Collinsworth.
- Absent: Public Works Director Ron Hitch.

Public Hearing, Municipal Aid Road Fund:

- Resolution 21-05 adopting and approving the execution of a Municipal Aid Co-op Program contract between the incorporated City and the Commonwealth of Kentucky, Transportation Cabinet, Department of Rural and Municipal Aid for the fiscal year beginning July 1, 2021, as provided in the Kentucky Revised Statutes and accepting all streets referred to therein as being streets which are a part of the Incorporated City. There was no public input from the audience. Chris Ampfer made a motion. Paul Kloeker seconded the motion. All in favor. **Motion passed.**

Ordinance 21-1069:

- 2nd reading to adopt an ordinance adopting the City of Cold Spring, Kentucky amended budget for the fiscal year July 1, 2020 through June 30, 2021. Lisa Cavanaugh made a motion. Paul Kloeker seconded the motion. Roll call vote shows 6 yeses and 0 noes. **Motion passed.**

Ordinance 21-1070:

- 2nd reading to adopt an ordinance adopting the City of Cold Spring, Kentucky annual budget for the fiscal year July 1, 2021 through June 30, 2022. Adam Sandfoss made a motion. Chris Ampfer seconded the motion. Roll call vote shows 5 yeses and 1 no - Moore. **Motion passed.**

Ordinance 21-1071:

- 2nd reading to adopt the City of Cold Spring 2022 Pay Plan. Deanna Hengge made a motion. Chris Ampfer seconded the motion. Roll call vote shows 5 yeses and 1 no - Moore. **Motion passed.**

Ordinance 21-1072:

- 1st reading to approve an ordinance amending the zoning map of the City of Cold Spring, County of Campbell, Kentucky for an approximate 1.0 acre on Alexandria Pike/US 27 approximately 600 feet north intersection of Alexandria Pike and Crossroads Boulevard from Highway Commercial* (HC*) to Highway Commercial (HC). Adam Sandfoss made a motion. Chris Ampfer seconded the motion. There was some discussion about the entrance and exit of the proposed development as well as the layout of the drive-thru. Adam Sandfoss made a motion. Chris Ampfer seconded the motion. Roll call vote shows 6 yeses and 0 noes. **Motion passed.**

Resolution 21-06

- Authorizing the Mayor to execute loan documents for the Cold Spring city projects, city recreation center, police department and amphitheater. Adam Sandfoss made a motion to approve. Chris Ampfer seconded the motion. There was discussion about the length and interest rate of the loan. All in favor. **Motion passed.**


