- Award trash bid – There was discussion as to why Rumpke was the only company to submit a bid; Rumpke said this is the 3<sup>rd</sup> city in Northern Kentucky where they have been the only bidder. The bid submitted was about a 4% increase and there are no fuel surcharges in our contract. Paul Kloeker made a motion. Lisa Cavanaugh seconded the motion. Roll call vote shows 4 yeses and 0 noes. **Motion passed.**

- There was no action taken during the executive session.


*Adjournment:*
