Cold Spring Council Minutes November 14,2022

The November 14, 2022 Caucus meeting was called to order by Mayor Penque at 7:30pm.

- Mark Majors (215 Ridgepointe Drive) advised council of the Playground Committee meeting that was held on November 10. He explained to council what the goal is for Municipal Park. The committee feels that the city should start fresh on Municipal Park and make it a top-notch park; another main goal is to add ADA compliant pieces to the park. Mr. Majors suggested that the city ask for sponsors to raise extra money for this project as well as look into grants that may be available. Ron Hitch gave some supporting information to council; such as the available funds from ARPA (American Rescue Plan Act), he stated that Public Works may be able to do some work in-house, and there is still a lot of information that needs to be gathered. Mayor Penque stated that Ron Hitch will be the chair of the committee going forward.
- Laura Vroegindewey (14 Goetz Drive) addressed council to make sure that the committee had the
 support of council as this project could be pricey. Steve Taylor stated that there is \$940,000 from APRA
 funds that have been assigned to park improvements. Ms. Vroegindewey stated that people have
 complained that there is water settling at Patriot Park which is causing an issue with bugs. There was
 discussion about drawings from the engineers, and whether or not those would be helpful in planning
 these updates.
- Tyler Owen (5696 Weaver Lane) stated that Municipal Park needs to be the premier park of the city and
 it needs to have features for all age groups. Mr. Owen also stated that ADA equipment is a must at this
 park.
- Roger Heck (6563 Murnan Road) said that the lights are out at the entry way of the city building.
- Tom Travis (704 Spireridge Court) was curios about the redesigning of the website. Robin Morency stated that she is working with the website company to simplify the website which will make it easier to navigate. Mr. Travis thanked the City Clerk and Public Works Director for their help with fixing an issue at Patriot Park. He also thanked everyone in attendance at the October caucus meeting, with a special thanks to the city attorney. Mr. Travis handed out a packet sharing concerns with how the council voted on the current pay plan. Mr. Sebastian Torres was in attendance in place of the city attorney Brandon Voelker, he stated that he will pass this along to Brandon Voelker for review.
