- Ordinance 23-1082, 2nd reading of an ordinance adopting the City of Cold Spring, Kentucky amended budget for the fiscal year July 1, 2022 through June 30, 2023. Lisa Cavanaugh made a motion. Paul Kloeker seconded the motion. Roll call vote – 3 yeses and 1 no – Guidugli. **Motion passed.**
- Ordinance 23-1083, 2nd reading of an ordinance adopting the City of Cold Spring, Kentucky annual budget for the fiscal year July 1, 2023 through June 30, 2024. Chris Ampfer made a motion. Paul Kloeker seconded the motion. Roll call vote – 3 yeses and 1 no- Guidugli. **Motion passed.**
- Ordinance 23-1084, 2nd reading of an ordinance to adopt the City of Cold Spring, Kentucky pay plan for the fiscal year July 1, 2023 through June 30, 2024. Chris Ampfer made a motion. Lisa Cavanaugh seconded the motion. Roll call vote – 4 yeses and 0 noes. **Motion passed.**

New Business:

- Resolution 23-03, a resolution authorizing the mayor to enter into an amendment joining the City of Cold Spring to the Northern Kentucky Swat Team (NKST). Chief Collinsworth explained the reasoning for this resolution and stated that one Cold Spring officer is trying out for the team. Paul Kloeker made a motion. Lisa Cavanaugh seconded the motion. All in favor. **Motion passed.**

- Public Works – Ron Hitch addressed complaints in regards to the geese at Barth Lake Park. Dave Guidugli thanked Ron Hitch for his assistance with construction issues and for placing the No Outlet signs on Darlas.
- Code Enforcement – Dave Guidugli asked for updates on the County Square parking space sizes. Chief Collinworth stated that this is still being investigated as parking space sizes measure throughout the city vary in size. There was discussion about trees at Crossroads Boulevard, the Goetz TV property and a garage on Marian Drive.

- Chris Ampfer said he likes that Barleycorn's has joined our summer concert series and he is looking forward to the rest of the concerts.
