

ORDINANCE 25-1100 AN ORDINANCE ADOPTING THE CITY OF COLD SPRING, KENTUCKY ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2025 THROUGH JUNE 30, 2026

Whereas, an annual budget proposal and message have been prepared and delivered to the legislative body: and,

NOW, THEREFORE, BE IT ORDAINED BY the City of Cold Spring Kentucky as follows:

SECTION ONE: That the annual budget for the fiscal year beginning July 1, 2025 and ending on June 30, 2026 is adopted as set forth herein:
