Cold Spring Council Minutes
October 13, 2025

The October 13, 2025 special council meeting was called to order by Mayor Penque at 7:30pm.

Prayer and pledge were led by the city clerk.

Roll Call & Exit Instructions:

- Present: Mayor Penque, Chris Ampfer, Lisa Cavanaugh, Steve Cunningham, Cindy Moore, Adam Sandfoss, Laura Vroegindewey, City Clerk Robin Morency, Public Works Director Ron Hitch, Police Chief Steve Collinsworth, and Attorney Brandon Voelker.

Minute Approval:

- September 22, 2025 meeting minutes were reviewed by all. Steve Cunningham made a motion, seconded by Lisa Cavanaugh. All in favor. None opposed. **Motion passed.**

Citizen Comments: None.

Ordinance 25-1103:

- 2nd reading to adopt an ordinance prohibiting activities on public roadways with medians. Lisa Cavanaugh made a motion, second by Steve Cunningham. Roll call vote shows 6 yes and 0 no. **Motion passed.**

Approval of job description and inclusion of Director of Operations in the pay plan:

- Adam Sandfoss made a motion, second by Chris Ampfer. Roll call vote shows 6 yes and 0 no. **Motion passed.**

Ordinance 25-1104:

- 1st reading to approve an ordinance amending the City of Cold Spring budget and pay plan for the fiscal year July 1, 2025 through June 30, 2026. Chris Ampfer made a motion, second by Adam Sandfoss. Lisa Cavanaugh requested clarification on the items included in the budget amendment. The amendment provides funding for the Municipal Park playset addition, replacement of the Friendship Park playset, adjustments to the pay plan, and participation in Social Security. There was discussion about the timeline for the playground upgrades. Roll call vote shows 6 yes and 0 no. **Motion passed.**

Ordinance 25-1105:

- 1st reading to approve an ordinance amending the City of Cold Spring's Code of Ordinances RE: Peddlers, Itinerant merchants, and solicitors. Lisa Cavanaugh made a motion, second by Cindy Moore. Cindy Moore wanted to clarify that this would not include school organizations and non-profits. There was discussion about the violations for those who may be non-compliant. Roll call vote shows 6 yes and 0 no. **Motion passed.**

Adjournment:

- Laura Vroegindewey made a motion to adjourn the meeting at 7:45pm, seconded by Lisa Cavanaugh. All in favor. None opposed.
